Running Order Saturday:

Sandi Talerico will judge Trial 1 handler discrimination, Novice – Master beginning at 9:00. Beginning at 11:00 Deb Hebler will judge Trial 2 vehicles, Novice – Elite.

Running Order Sunday:

Sandi Talerico will judge Trial 1 Vehicles, Novice - Elite beginning at 9:00. Beginning at 11:00 Deb Hebler will judge Trial 2 exteriors, Novice – Elite.

**Awards:** Qualifying ribbons, rosette ribbons for 1<sup>st</sup> through 4<sup>th</sup> place for Level A exhibitors, strip ribbons for 1<sup>st</sup> through 4<sup>th</sup> place Level B exhibitors, Title rosette ribbons.

**After the handler discrimination trial all exhibitors are welcome to crate their dogs in our large training room as the other three trials will take place outdoors.**

## **Directions to the site:**

Wolverine Dog Training Club, 20782 Orchard Lake Road 48336; From the west: Take M14/I-96 past I-275 to Merriman Road exit. Turn left (north) on Merriman Rd. and continue 4 miles to just past 8 Mile Rd. Turn right into second driveway. (Note: Merriman Rd. changes its name to Orchard Lake Rd. north of 8 Mile.) From the south take I-275 to 8 Mile Rd. exit. Turn right on 8 Mile and go about 4 miles to Orchard Lake Rd. Turn left on Orchard Lake Rd., then turn right into the second driveway. From north or east: take I-696 to the Orchard Lake Rd. exit. Then turn south on Orchard Lake Rd. At Grand River, turn left, then right to continue on Orchard Lake Rd. Continue south on Orchard Lake almost to 8 Mile Rd. Wolverine is the second to last driveway on the left.
