Running Order Saturday:

Deb Kramer will judge PTs beginning at 9:00. Trial 1 PT, Novice-Elite will be followed by Trial 2 PT Novice-Elite. After PTs are completed Deb Kramer will judge a Vehicle Trial, Novice-Elite. Cheryl Carlson will judge an Exterior Trial, Novice-Elite beginning at 1:00.

Running Order Sunday:

Cheryl Carlson will judge PTs beginning at 9:00. Trial 1 PT, Novice-Elite will be followed by Trial 2 PT Novice-Elite. After PTs are completed Cheryl Carlson will judge a Vehicle Trial, Novice-Elite. Deb Kramer will judge an Exterior Trial, Novice-Elite beginning at 1:00.

Awards: Qualifying ribbons, rosette ribbons for 1st through 4th place for Level A exhibitors, strip ribbons for 1st through 4th place Level B exhibitors, Title rosette ribbons, High in Trial rosettes and High Scoring Junior rosettes.

Wolverine Dog Training Club, 20782 Orchard Lake Road 48336; From the west: Take M14/I-96 past I-275 to Merriman Road exit. Turn left (north) on Merriman Rd. and continue 4 miles to just past 8 Mile Rd. Turn right into second driveway. (Note: Merriman Rd. changes its name to Orchard Lake Rd. north of 8 Mile.) From the south take I-275 to 8 Mile Rd. exit. Turn right on 8 Mile and go about 4 miles to Orchard Lake Rd. Turn left on Orchard Lake Rd., then turn right into the second driveway. From north or east: take I-696 to Orchard Lake Rd. exit. Turn left, then turn right onto Orchard Lake Rd. Continue south on Orchard Lake almost to 8 Mile Rd. Wolverine is the second to last driveway on the left.
